Ellsworth Community Clean Water Project NEXT NEWSLETTER on Track to Begin Construction in 2024

An Air Force-funded project to install a waterline serving residents near Ellsworth AFB is on track to begin construction in

In Oct. 2022, the Air Force's effort to provide a permanent source of water to per- and polyfluoroalkyl substances (PFAS)-impacted residents near Ellsworth AFB came to a standstill when Meade County denied a permit application to install a waterline in the county right-of-way.

Soon after this setback, Pennington County and the Public Works Directors of Rapid City and Box Elder offered support for an alternate plan located solely within Pennington County. After several months of partnering meetings with representatives from Rapid City, Box Elder, Pennington County, Air Force, and the S.D. Ellsworth Development Authority (SDEDA), a new plan emerged. On Jan. 31, 2023, a "handshake agreement" was announced in a press conference.




Figure 1. Proposed New Waterline.

Under the new plan, a waterline will be designed and built by SDEDA to supply water to the impacted residents in Areas A and B (see Figure 1). Once built, Rapid City will supply water and own the line west of Elk Vale Road. Box Elder will own the line east of Elk Vale Road.

The new waterline will benefit the entire community surrounding Ellsworth AFB and will provide a much-needed additional connection between Rapid City, Box Elder, and Ellsworth AFB.

Tentative plans call for household connections to occur in 2025. The Air Force will continue to operate treatment systems or provide bottled water to PFAS-impacted residents until households are hooked up to the new waterline.

After hookups are complete, PFAS-impacted residences will begin receiving drinking water from the new waterline, the Air Force will stop providing alternate water, and treatment systems will be removed.
