Welcome to Ellsworth AFB's Restoration Newsletter

Based on feedback we received from the community, we learned one of the best ways to get in touch with those in our area is through direct mailings. In response to this feedback, the Ellsworth AFB Environmental Restoration Program will publish a newsletter twice a year in conjunction with Restoration Advisory Board meetings. The newsletter is a way we can get information out to community members interested in the Ellsworth AFB Superfund Site cleanup program. East Waterline Update -

When the City of Box Elder took over the operation of the east water supply line from Ellsworth AFB in March 2007, several landowners requested permission to install irrigation wells in restricted areas. The Air Force then decided to evaluate alternatives to expedite the beneficial use of the off-base groundwater.

Ellsworth AFB has finalized an *Exit*Strategy Report for the Off-Base
Groundwater Plume in October
2010. The report outlines a short
term strategy to allow landowners to
install new wells, or use existing
wells, within the off-base plume and
pump the groundwater for nonpotable purposes.

Please note, non-potable water is unfit for humans to drink, but is clean enough for a variety of other uses, such as:

- Landscape Irrigation
- Garden Irrigation
- Swimming

The groundwater investigation and human health risk assessment docu-

mented in the Exit Strategy Report indicate that non-potable use of groundwater in the off-base plume would not result in unacceptable human health risks.

The Air Force Center for Engineering and the Environment granted concurrence to move forward on the limited non-potable beneficial use of groundwater for off-base residents on December 16, 2010.

The Air Force, Environmental Protection Agency, and South Dakota Department of Environment and Natural Resources (SDDENR) approval document (Explanation of Significant Differences) must be signed before the Base will be able to start modifying Memorandum of Agreements (MOAs). The scheduled date for signing the document is April 26, 2011.

If you are interested in the limited non-potable beneficial use of ground-water (using a new or existing water well), please submit your written request with a site map showing the new or existing well location to the Ellsworth AFB environmental office:

After submitting your request, new MOAs will have to be prepared and legally reviewed before new or existing wells will be allowed to be used. Costs associated with drilling new wells, installation of pumps/hydrants, and/or operation of existing wells are borne by the landowner. The landowner must also comply with all applicable regulations.

Proposed Plan -

The Air Force is currently preparing a proposed plan which identifies the preferred alternatives for cleaning up the contaminated groundwater onbase at the OU-II Basewide Groundwater Operable Unit, and provides the rationale for this preference. The

proposed plan will be available for public comment this summer at the Information Repository (South Dakota Air & Space Museum). Additionally, a public meeting will be held to discuss the proposed plan. An announcement will be printed in the
