### **TECHNICAL SERGEANT SUSAN L. DAVIS**

Technical Sergeant Susan L. Davis is the Acting Law Office Superintendent for the Office of the Staff Judge Advocate, 28th Bomb Wing, Ellsworth AFB, South Dakota. In this capacity, she serves as the principal advisor to the Staff Judge Advocate on enlisted matters and oversees the daily operations of the legal office with manpower, budget, training, and assists with delivering legal services to more than 4,300 personnel to the largest B-1 combat wing in the U.S. Air Force.

TSgt Davis is from San Antonio, Texas, and entered active duty in July 2008. She graduated from the Basic Public Affairs Writer technical training course at Ft. Meade, Maryland, in December 2008. Her first assignment was to the 11th Wing Public Affairs Office at Bolling AFB, District of Columbia, where she worked in Command Information, Community Engagement, and Media Operations. In 2012 she was



reassigned to the 319th Air Base Wing Public Affairs Office, Grand Forks AFB, North Dakota, where she later became NCOIC of Media Operations and Community Engagement. There, TSgt Davis also became certified as a Master Resiliency Trainer and a Volunteer Victim Advocate for the SAPR office. She was selected via the Developmental Special Duty program to become an Airman Leadership School Instructor in May 2016. She has taught more than 3,000 podium hours and was instrumental in the growth and development of nearly 400 firstline supervisors. She completed her retraining into the Paralegal career field in September 2020.
