Restoration Advisory Board (RAB) Interest Assessment Underway Through April 30, 2023

The Air Force is assessing community interest in re-establishing the RAB.

Restoration Advisory Board vs. Public Meeting

Many people have casually expressed interest in reinstating the Ellsworth RAB: so we wanted to compare and contrast a formal RAB versus Public Meetings.

RAB

involvement in the environmental restoration process at current and former Department of Defense properties. Regulations regarding the scope, characteristics, composition, funding, establishment, operation, adjournment, and dissolution of a RAB are in Title 32, Code of Federal Regulations, Part

The RAB is a formal board made up of Government and Community members which follows formal procedures (similar to a city council meeting). The RAB receives and discusses information and can make comments or recommendations. RABs have no decision making role in restoration activities.

The RAB holds meetings that are open to the public; however, all public questions or comments may not be heard during the meeting due to time constraints and would have to be submitting in writing for

follow-up. Also, RABs discuss the entire environmental restoration program at the installation, not just one specific site, activity, or issue.

Public Meeting

Public meeting are more flexible The purpose of a RAB is stakeholder than RABs. They are held to share information and can discuss specific topics or the entire restoration program. Public meetings allow community members to express their opinions and receive information on specific topics, such as PFAS.

Compare and Contrast

Ellsworth had a formal RAB established in the 1990s which dissolved in the 2000s due to lack of community interest. Public meetings continued under the "RAB Meeting" title; however, they were just regular public meetings since the RAB was dissolved.

During the 2021 RAB interest assessment, the focus of community interest was solely PFAS issues. There was no interest expressed in the other environmental restoration activities on Ellsworth AFB. According to DOD regulations, the

RAB's focus must be broader than

one restoration site or activity. Currently, the community is kept informed through this newsletter, the Administrative Record, the Environmental Matters Website. one-on-one meetings (held as needed/requested), and the public meetings hosted by the Pennington County Board of Commissioners. The Air Force receives valuable

feedback from community members

as a result of these efforts.

Due to the Global COVID-19 pandemic, public meetings of all kinds came to a screeching halt. As we have been able to get back to meeting in person, Pennington County, Air Force, and U.S. EPA have collaborated to provide a Community Town Hall forum and the March 2022 public meeting was well attended and highly effective in the hybrid in-person/online format. A RAB would be another way to

accomplish the same thing, but it would come at a cost by diverting resources away from the current programs and into the RAB.

Programs at risk of discontinuation include this newsletter, one-on-one meetings, and individualized mailings.
