Technical Sergeant Jamie M. Sutton is the Noncommissioned Officer in Charge (NCOIC) of the Legal Office for the Office of the Staff Judge Advocate, 28th Bomb Wing, Ellsworth AFB, South Dakota. In this capacity, she serves as the principal advisor to the Staff Judge Advocate on enlisted matters and oversees the daily operations of the legal office with manpower, budget, training, and assists with delivering legal services to more than 4,300 personnel to the largest B-1 combat wing in the U.S. Air Force, and future home of the B-21.

TSgt Sutton is from Cloverdale, California, and entered active duty in April 2010. She graduated from Aerospace Apprentice technical training course at Sheppard AFB, Texas, in November 2010. During her time in Aerospace Maintenance, she was a Dedicated Crew Chief at Dyess AFB in charge of her own aircraft; a Flying Crew Chief at Ramstein where she flew missions all over Europe and Africa amassing 284 flight hours; a Repair and Reclamation Craftsman at Yokota AB Japan in charge of maintaining and replacing flight controls, landing gears and other major aircraft parts; and a Section Chief at Hurlburt Field in charge of over 100 personnel. She completed her retraining into the Paralegal career field in September 2022.
