Major J.R. Fallon is a CAT B Individual Mobilization Augmentee supporting the Staff Judge Advocate’s office, 28th Bomb Wing, Ellsworth Air Force Base, South Dakota – the largest B-1B Lancer combat wing in the U.S. Air Force, providing combat ready aircraft and support for global engagement taskings. The installation, with more than 12,000 active-duty military, civilian employees, and family members, will also serve as the primary future operating base of the B-21 Raider, the first strategic bomber in more than three decades. In addition to advising the Wing and subordinate commanders regarding military justice and operational law matters, he assists in delivering comprehensive legal services to more than 3,800 military, civilians and retirees.

In 2012, Maj Fallon enlisted in the Air Force Reserve and served in the 58th Aerial Port Squadron at Westover Air Reserve Base, MA. In March 2018, Maj Fallon received a direct commission and entered active duty as an Air Force Judge Advocate in March 2018. While on active duty, Maj Fallon served as a Special Assistant U.S. Attorney, an Area Defense Counsel, and deployed throughout the Middle East as the Staff Judge Advocate of a Special Operations Task Force. Maj Fallon is licensed to practice in NH, ME, MA, and the District of Columbia.
