SUBJECT: March 2017 Compliance Water Monitoring Results

1. During the month of March 2017, the Bioenvironmental Engineering Flight (BEF) collected eight samples from state approved sites. Sampling is performed each month based on monitoring frequency requirements outlined in AFI 48-144, *Drinking Water Surveillance Program*, Para 4.1., and South Dakota Department of Environmental and Natural Resources (SD DENR) guidance. Below is a summary of samples collected in the month of February.

2. Drinking water standards set by the Environmental Protection Agency (EPA) and SD DENR, prescribe acceptable levels of chlorine and pH within a water system. Chlorine residual is maintained between 0.2-2.0 mg/L and pH at levels between 6.5 and 8.5. All samples are in compliance with EPA and state standards.
